

Dichiarazione di Indipendenza del Principato di King Peninsula

Roma 8.10.2011

“Il principio di autodeterminazione dei popoli sancisce il diritto di un popolo sottoposto a dominazione straniera ad ottenere l’indipendenza, associarsi a un altro stato o comunque a poter scegliere autonomamente il proprio regime politico. Tale principio costituisce una norma di diritto internazionale generale cioè una norma che produce effetti giuridici (diritti ed obblighi) per tutta la Comunità degli Stati. Inoltre questo principio rappresenta anche una norma di ius cogens, cioè diritto inderogabile.”

Conseguentemente a questa enunciazione,

- Visto quanto sancito dal “*Patto internazionale sui diritti civili e politici*”, stipulato nell’ambito dell’ONU nel 1966 e dalla “*Dichiarazione relativa alle relazioni amichevoli ed alla cooperazione fra stati*” del 1970;
- Valutato l’Atto Finale con il quale si è espressa la “Conferenza per la Sicurezza e la Cooperazione in Europa” (CSCE) in Helsinki del (1975);
- Vista la domanda di S.A.S. Eugenio LAI, Principe della Penisola del RE localizzata alle coordinate: 72°12'S 100°15'W 72.2° S 100,25° W lunga 100 e larga 20 miglia circa, tendente alla totale indipendenza politica, amministrativa, militare, etc, di detta penisola e delle relative pertinenze;

Dichiarato il “**NULLA OSTA**” da parte del Consiglio Supremo dello Stato di Antarcticland che all’unanimità dei suoi membri delibera, accetta e conferma la Sovrana Indipendenza del Principato di King Peninsula e lo rende “LIBERO” da ogni e qualunque eventuale precedente pretesa sul territorio e su quanto eventualmente pertinente, previa sottoscrizione del presente atto di indipendenza.

In virtù e per effetto di questo atto,

è da oggi proclamata la piena ed assoluta indipendenza del

“Principato di King Peninsula”,

localizzato nella omonima penisola alle coordinate: 72°12'S 100°15'W


**con la piena Sovranità delle terre, delle acque, dei mari con l'estensione delle
acque internazionali di navigazione, e degli spazi aerei.**

Il Principato di King Peninsula potrà autogovernarsi autonomamente ovvero secondo la politica che vorrà democraticamente portare avanti, anche attraverso l’unità dei paesi o formule ad esso congeniali.

La presente Dichiarazione di Indipendenza è irrevocabile ed inappellabile.



Declaration of Independence of King Peninsula Principality

Rome, Italy 2011.09.08

"The principle of people self-determination sanctions the right to obtain independence, to associate to another state or to choose autonomously its own political system, for a people dominated by a foreign power. This principle constitutes a rule of general international law, that is a rule which produces legal effects (rights and obligations) for the entire Community of States. Furthermore, this principle represents a rule of *ius cogens*, that is a mandatory right."

Following this statement,

- In view of what has been sanctioned by UNO in the "International Covenant on Civil and Political Rights" in 1966 and in the "Declaration on Principles of International Law concerning Friendly Relations and Co-operation among States" in 1970;
- Valued the Final Act of the "Conference on Security and Co-operation in Europe" (CSCE) in Helsinki in 1975;
- In view of the application for the complete political, administrative, military, etc. independence of this peninsula and its pertinences, presented by H.S.H. Eugenio Lai, Prince of the King Peninsula, localized at these coordinates: 72°12'S 100°15'W, 100 miles long and 20 miles wide; With the authorization ("nullaosta") of the Supreme Council of the Antarcticland State, its members unanimously resolve, accept and confirm the Sovereign Independence of the King Peninsula Principality and make it "FREE" from every single possible previous claim on the territory and on every possible pertinence, subject to the signature of the present independence act.

By virtue of the present act,

To day we declare the full and absolute independence of
"King Peninsula Principality",

localized on the homonymous peninsula at the following coordinates: 72°12'S 100°15'W
with the full Sovereignty of lands, waters, seas, with the extensions of the international
shipping waters and of the flight areas.

The King Peninsula Principality can self-rule autonomously or follow its own democratic politics, even with the unification of the states or in other congenial ways.

This Independence Declaration is irrevocable and unappellable.

- Having seen 'the clearance' dated 12th April, 2011, of HE, the Prime Minister, with this Decree of Investiture, with effect of all the requisites of Law and of the Noble Right of the State, and the International Conventions with particular reference to the Principle of the Self determination of the Peoples, hereby declares to confer the petitioner to the dignity of

Prince

Having the right to add by way the relative noble title which pertains His Serene Highness, in short, SAS, by name and surname.




